Merger between Tasmania CRA and Victoria






TACR has 5 members. At a special resolution mtg of TACR members on 5th August 2022 the members resolved to:

- 1. De-register the Tasmanian Association of Cardiovascular Health and Rehabilitation (TACR);
- 2. Add current TACR members to the ACRA VIC state register;
- 3. Any future health professionals who live and work in Tasmania who are interested in becoming members of ACRA be registered on the ACRA VIC state register;
- 4. Retain a position on the ACRA EMC for an ACRA member who lives and works in Tasmania. This position would serve to be the voice for Tasmanian cardiac rehabilitation professionals on ACRA EMC and to promote ACRA within Tasmania;
- 5. All TACR funds and assets are distributed in accordance with this resolution:
 - a. \$4000 to go to support of the ACRA Anna Storen Regional Travel Grant
 - b. remaining funds including shares to be transferred to ACRA VIC for the purpose of supporting professional development requests by Tasmanian-based members of ACRA.
 - c. any current or future ACRA member who lives and works in Tasmania be eligible to apply for professional development support available through funds formerly owned by TACR as outlined in 5b) above.

ACRA national COVID impact survey





- At the 2021 AGM it was suggested by ACRA member, Dr Jan Cameron to survey members on COVID impact
- Formed a subcommittee of EMC plus co-opted ACRA members with skills (16 clinicians, researchers and policy developers)
- Purpose: how COVID has changed CR and describe what services look like 3 timepoints were surveyed;
- Pre-COVID,
- March –Dec 2020
- At time of survey completion in March 2021







- Results have been presented by Drs Emma Thomas and Susie Cartledge at this meeting.

ACRA/CSANZ telehealth position statement





<u>Objective</u>: a national position statement on telehealth and remote cardiovascular care and cardiac rehabilitation delivery that informs sustainable implementation and integration into the healthcare system

<u>Purpose</u>: to provide practical information to guide high quality standards of cardiovascular care.

ACRA/CSANZ telehealth position statement





The position statement will be structured with four sections:

- 1. Principles for remote cardiovascular (including cardiologist) consultation
- 2. Principles for remote delivery of cardiovascular rehabilitation,
- 3. Principles for remote delivery of multidisciplinary and nurse-led programs of care,
- 4. Principles for remote delivery of nurse practitioner-led programs of care.
- 5. Many of our ACRA members are involved

Education: 1325 cardiac rehabilitation professionals have undertaken our Cardiac Rehabilitation Foundations Certificate Advocacy. Delivered four free webinars in the last year partnering with AACVPR and in Oct, EAPC),

Quality: International Cardiac Rehabilitation Register (ICRR) and new CR Accreditation Program,

Advocacy: we have contributed to the World Health Organisation Package of Rehabilitation Interventions and we produced the first Women-Focussed Clinical Practice Guidelines which ACRA endorsed,
