Treasurer Report			
		<p>Opened the 2023 financial year with \$133454 in total assets. The main assets include a Cash Account an interest-bearing Saving account, which was unchanged interest transferred to the Cash account.</p> <p>A new asset was created as a result of the merger between Victorian and Tasmanian ACRA branches, \$13,759 was transferred from Tasmanian ACRA</p> <p>Liabilities include a small negative GST liability. However, the association has not been registered for GST since FY2020.</p> <p>A decrease in net assets compared with FY2022 (-\$29,890) related to banking conducted on behalf of ACRA Queensland for the 2022 Annual Scientific Meeting (2022 ASM). Income was split across FY2022 (\$50,758) and FY2023 (\$40,330) yet all funds were expended in FY2023(\$91,087)</p> <p>A Venue Hire expense from Q3 FY2023 has not yet been invoiced. This represents a liability estimated at \$4,500.</p> <p>FY2023 income was Capitation, Sponsorship, and Event Registrations. Capitation (\$4,240) is a pro rata contribution from ACRA national related to the size of the Victorian and Tasmanian membership. Sponsorship(\$4,500)was derived from biannual ACRA Victoria and Tasmania professional development events. This has decreased 50% from FY2022. MostFY2023 Event Registration income was from the 2022 ASM (\$40,330), and only held temporarily on behalf of ACRA Queensland. Event registration income from ACRA</p>	<p>Treasurer report moved and accepted by Erin Howden and Katie Palmer</p>

		<p>Victoria and Tasmania’s biannual professional development events contributed a further \$10,795.</p> <p>Key FY2023 expenses were Venue Hire(\$48,846),Grant Schemes (\$4,490), and Event Services(\$1,631). Most Venue Hire expenses related to the 2022 ASM (\$44,631), were paid to a supplier on behalf of ACRA Queensland. Venue Hire for biannual ACRA Victoria and Tasmania professional development events totalled \$4,215. Advocacy expenses (\$495) included costs of attending cardiovascular health fora to increase representation and advocate for causes aligned with the association's mission. Other Expenses (\$46,678) represent the transfer of the remaining 2022 ASM income to ACRA Queensland.</p> <p>The overall net surplus was significantly impacted by 2022 ASM transactions conducted on behalf of ACRA Queensland.Total2022 ASM income(\$91,087) was split across FY2022 (\$50,758)and FY2023 (40,330) while related expenditure(\$91,087) was all conducted inFY2023.Transactions ultimately balanced to \$0.</p> <p>Linda Macaulay: Thank you to Jono for all your work on the treasurer report.</p> <p>Susic Cartilage: we need help from members with ideas on how to spend these funds to support our members.</p>
