- Balance sheet: FY24 net assets \$126,704
  - o \$500 unpaid sponsorship revenue still to be collected
  - Profit/loss: FY24 \$6,870 loss
    - o Capitation unexpectedly low. Following up with TAS.
- Events:
  - 2023 state conference \$630 surplus (\$500 sponsorship revenue outstanding)
  - o 2024 clinical practice day \$1,401 surplus

Kath Kelly: Capitation needs be checked to see why we have had such a large drop.

Susie Cartledge: We are in a good financial position, so please let us know how we can give this money back to you in useful ways, any grants or training that can help members.

Judith Enright: can we ensure that travel grants can be awarded before the conference? Reimbursement methods mean that some people may miss out. We do have specific money set aside for Tas.

We have grants for people travelling from regional areas to travel to our events.
